1. Participation in this “Pick-a-box” promotion constitutes an acceptance of these Terms and Conditions of Participation.

ENTRY

2. Patrons may gain an entry ticket into the competition via two (2) methods:

	ENTRIES	METHODS
Alpha	One (1) entry only on day membership application approved	Advantage program membership application: a patron who has, during the “Entry Period” applied, and been accepted, for an <i>Advantage</i> program membership, may lodge an entry ticket into the draw on the day of approval. ¹
Bravo	One (1) entry only per day during “Entry Period”	Existing Advantage program members: a patron who is an existing Advantage program member may, during the “Entry Period”, other than on a day where the patron is accepted for an Advantage program membership (if applicable), present his/her membership card at the VIP Host desk at the Location and lodge an entry ticket into the draw.

3. The “Entry Period” begins at **12pm on Monday, 20 March 2017**, and ends at **7:30pm** on the day of “Pick-a-Box” – **Saturday, 22 April 2017**. Late entries will not be accepted.
4. Participants are responsible for obtaining an entry ticket from the VIP Host desk and placing the entry ticket into the marked barrel during VIP Host desk operating hours during the “Entry Period”.

PRIZE DRAW

5. The prize draw to identify the winners of the promotion shall be held at **8:00pm on Saturday 22 April 2017** in Onyx Lounge.
6. Eight (8) entries shall be randomly drawn from the marked barrel on-site at the Draw Location by a representative of Casino Canberra (“**Drawn Entries**”). A Drawn Entry can only be confirmed as valid when a representative of Casino Canberra has selected a complete and legitimate entry ticket featuring the associated entry date, the participant’s full name, and the participant’s identification

number (assigned by the Advantage program). If a Drawn Entry is deemed to be an invalid entry, the draw in respect of that entry shall not be considered valid and an additional entry shall be drawn.

7. The names and membership numbers of the first eight (8) valid Drawn Entries shall be announced and broadcasted through the casino audio system. Participants accept full responsibility for being able to hear and understand draw announcements.
8. To claim a prize, a selected participant must present themselves to a representative of Casino Canberra at the Draw Location within three (3) minutes of their name and membership number being announced ('**Presentation Period**'). Casino Canberra may, at any time (including after the Presentation Period expires) and at its sole and absolute discretion, extend the Presentation Period ('**Extended Presentation Period**') applicable to any particular selected participant, if that participant:
 - a. is on the premises of Casino Canberra during the Presentation Period and has attempted to present themselves at the Draw Location during the Presentation Period, or is in the course of attempting to present themselves at the Draw Location when the Presentation Period expires; and
 - b. has identified themselves to a representative of Casino Canberra during the Presentation Period.

A selected participant must produce their current and valid Advantage membership card to a representative of Casino Canberra at the Draw Location (subject to Casino Canberra reserving the right to waive this requirement where the identity of the participant is determinable without the assistance of the Advantage membership card).
