Promotion Details:

Promotion Name:	Double Down Wednesday
Date:	Every Wednesday from 2nd January 2019 to 26th June 2019
Time:	12:00pm – 4:00am
Target:	All eligible Infinity Program members
Location:	Casino Canberra, 21 Binara Street, Canberra

1. This promotional offer (known as the “Double Down Wednesday” promotion) is open to Infinity Rewards program members (only).
2. Participation in the promotion constitutes an acceptance of these Terms and Conditions (which operate in conjunction with the Infinity Rewards Rules).
3. The promotion shall be conducted every Wednesday from **12:00pm until close of trade (4:00am, Thursday morning)** from **2nd January 2019 to 26th June 2019** (each a ‘Promotion Day’).
4. **Number of participants:** There is no minimum or maximum number of participants per promotion.
5. **Redemption:** Infinity Rewards program members, using the requisite number of Infinity Rewards program points, may redeem Single Bet Promotional Chips, by presenting their Infinity Rewards program membership card at the VIP Desk on each Promotion Day and requesting a redemption.
6. **Operation :**
 - 6.1 Subject to this document, during each Promotion Day, Infinity Rewards program points that have been accrued by an Infinity Rewards program member, are worth ‘double’ their usual value for the (sole) purpose of the member redeeming Single Bet Promotional Chips.
 - 6.2 For example, on a Promotion Day, an Infinity Rewards program member can use:
 - 6.2.1 20,000 Infinity Rewards program points (accrued by the member), to redeem \$400 worth of Single Bet Promotional Chips; or
 - 6.2.2 5,000 Infinity Rewards program points (accrued by the member), to redeem \$100 worth of Single Bet Promotional Chips.

- 6.3 On each Promotion Day, a minimum of 1,250 Infinity Reward program points and a maximum 50,000 Infinity Rewards program points can be used by an Infinity Rewards program member to redeem Single Bet Promotional Chips at the 'double' rate (according to **paragraph 6.1** above). Any other redemption of Single Bet Promotional Chips by the member will be at the usual redemption rate.
- 6.4 The amount of points redeemed must be a multiple of 1,250.
7. In the event that the promotion cannot be conducted at, or during, the specified times, due to unforeseen circumstances outside of Casino Canberra's control, the promotion will take place as soon as is practicable after the delay has been resolved.
8. The conduct of the promotion, including decisions with respect to eligibility, is the responsibility of Casino Canberra (via authorised members of the management team). Casino Canberra's decisions in relation to the promotion will be considered final and binding on every participant.
