PROMOTION

1. Participation in the “Money Tree Promotion” (**Promotion**) constitutes an acceptance of these terms and conditions.

2. The Promotion shall:

2.1 commence at 12pm, Saturday, 24 September 2022; and

2.2 end on the earlier of:

a. the time by which the 249 “Coins”, available to be drawn in accordance with these terms and conditions, have been drawn; or

4am, Sunday 25 September, 2022

(‘**period of the Promotion**’).

Entry into promotion

3. During the period of the Promotion (and subject to **paragraphs 4 – 5** below), an existing *Infinity Rewards* program member (**Member**) may obtain an entry into the Promotion by presenting their (valid and current) membership card at the VIP Host Desk at the Location.

4. A Member may not present a membership card of another member, in order to obtain an entry for that other Member.
5. A member may obtain no more than one (1) entry into the Promotion.

Prize draw

6. On obtaining an entry into the Promotion, the Member shall immediately draw (i.e. pick) a “Coin” from the money tree - which is located at the VIP Host Desk (**Draw Location**). Each time a “Coin” is drawn from the money tree, it shall not be returned to the money tree.
7. Each “Coin” shall contain a voucher (in a stated dollar amount) that entitles the Member who has drawn the “Coin” to an amount of non-negotiable promotional chips - which amount is to be calculated as follows:
 - 7.1 “**Gold**” Members shall receive the amount recorded on the voucher in non-negotiable promotional chips;
 - 7.2 “**Ruby**” Members shall receive five times (x5) the amount recorded on the voucher in non-negotiable promotional chips; and
 - 7.3 “**Diamond**” members shall receive ten times (x10) the amount recorded on the voucher in non-negotiable promotional chips.
8. The vouchers are to be redeemed for non-negotiable promotional chips (in the relevant amount) by the Member at the Cash Desk.
9. Subject to **paragraph 13**, there shall be no extension to the period of the Promotion (including, for the avoidance of doubt, in circumstances where all 250 “Coins” have not been drawn before the close of the period of the Promotion).
10. **Prize pool:**
 - 10.1 Subject to these terms and conditions, the value of the “Coins” (i.e. prizes) that are available to the Members participating in the Promotion (as determined by a Member’s *Infinity Rewards* program membership tier) shall be as follows:

- 10.2 The maximum value of the prize pool for the Promotion is an amount up to **\$100,000**.
11. Affiliates, contractors, directors, and/or employees associated with Aquis Entertainment and/or Casino Canberra are not eligible to participate in the Promotion.
 12. All prizes are strictly non-negotiable and non-transferable and are not redeemable for any other goods or services.
 13. In the event that a prize draw cannot be conducted at the specified time, due to unforeseen circumstances outside of Casino Canberra's control, the prize draw shall take place as soon as is practicable after the delay has been resolved.
 14. The conduct of the Promotion, including decisions with respect to the eligibility of persons to enter and the validity of entries and prizes, is the responsibility of Casino Canberra (via authorised members of the management team). Casino Canberra's decisions in relation to the Promotion will be considered final and binding on every participant.
 15. Guests must be aged eighteen (18) years or older in order to be eligible to access Casino Canberra (based at the Location) and/or participate in the Promotion.
 16. Persons who are 'excluded persons' are not eligible to access Casino Canberra (based at the Location) and/or participate in the Promotion.
