### PROMOTION

1. Participation in the “Lucky Wheel Promotion” (**Promotion**) constitutes an acceptance of these terms and conditions.
2. The Promotion shall:
  - a. commence at 8:30pm, on Saturday, 25 November; and
  - b. end on the earlier of:
    - i. the time by which 100 Members have been awarded a prize in accordance with these terms and conditions; or
    - ii. 11.59pm, Saturday, 25 November 2023

(‘**period of the Promotion**’).

### Entry into promotion

3. During the period of the Promotion (and subject to **paragraphs 4 – 5** below), an existing *Infinity Rewards program* member (**Member**) may obtain an entry into the Promotion by presenting their (valid and current) membership card at the VIP Host Desk at the Location.

4. A Member may not present a membership card of another Member, in order to obtain an entry for that other Member.
5. A Member may only obtain one (1) entry into the Promotion, and entry into the Promotion is on a first-come, first-serve basis during the period of the Promotion.

### Prize draw and prize pool

6. On obtaining an entry into the Promotion, a Member shall immediately spin the Lucky Wheel (**Wheel**) - which is located at the VIP Host Desk (**Draw Location**).
7. The Wheel shall consist of fourteen (14) segments. Of the fourteen (14) segments:
  - a. **One (1)** segment will be labelled - \$100;
  - b. **Two (2)** segments will be labelled - \$50; and
  - c. **Eleven (11)** segments will be labelled - \$25.
8. For a spin of the Wheel by a Member to be valid:
  - a. the Wheel must complete at least one (1) complete rotation; and
  - b. the motion of the Wheel must have ceased and the pointing device on the Wheel must be at rest in one of the segments on the Wheel.
9. A Casino Canberra representative shall announce the result from a valid spin of the Wheel (being either \$25, \$50, or \$100).
10. On spinning the Wheel, a Member shall be awarded a prize that:
  - a. corresponds to:
    - i. the segment where the pointing device on the Wheel is at rest (and its applicable dollar value); and

11. The NNPC vouchers shall be redeemed by Members for non-negotiable promotional chips (in the relevant amounts) at the Cash Desk.
12. The maximum value of the prize pool for the Promotion is an amount up to **\$100,000**.
13. Subject to **paragraph 16**, there shall be no extension to the period of the Promotion (including, for the avoidance of doubt, where 100 Members have not been awarded a prize before the end of the period of the Promotion).
14. Affiliates, contractors, directors, and/or employees associated with Iris Capital and/or Casino Canberra are not eligible to participate in the Promotion.
15. All prizes are strictly non-negotiable and non-transferable and are not redeemable for any other goods or services.
16. If a prize draw cannot be conducted at the specified time, due to unforeseen circumstances outside of Casino Canberra's control, the prize draw shall take place as soon as is practicable after the delay has been resolved.
17. The conduct of the Promotion, including decisions with respect to the eligibility of persons to enter and the validity of entries, spins, and prizes, is the responsibility of Casino Canberra (via authorised members of the management team). Casino Canberra's decisions in relation to the Promotion will be considered final and binding on every participant.
